The intakes in all programmes that come under the purview of statutory councils (MCI, DCI, PCI, AICTE, RCI, INC) are as approved/sanctioned/permited by the respective councils.</li> <li>2. The Institute strictly adheres to the sanctioned strength of the statutory councils</li> <li>3. In programmes that are not under the purview of the statutory councils, the intake is recommended by the respective Boards of Study and ratified by the Academic council and Board of Management.</li> <li>4. The increase in take in any of the programmes offered is based on statutory requirements, community and societal needs and availability of qualified teaching faculty, and infrastructure.</li> </ol>

<b>Procedure</b>	<ol style="list-style-type: none"> <li>1. Eligibility criteria for admission is followed as per the statutory body recommendations; Incase of the programmes which are not governed by the council’s eligibility criteria specified in the regulations recommended by the BOS and ratified in the Academic Council</li> <li>2. Total applications received will be scrutinized for the eligibility criteria prescribed for each of the programme</li> </ol>

	<p>3. Short listing of applications shall be done in the ratio of 1: 7 depending on the number of seats. Programmes offered are classified as Groups A and B</p> <p>4. Selection will be made on the basis of the marks secured by the candidates in the Entrance Examination and Interview scores.</p> <p>5. Intimation letter will be sent to the candidates provisionally selected for admission. Programme allotment will be made through counselling in the order of merit.</p> <p>6. In case of candidates who secure the same marks in the Entrance Examination, ranking will be made based on their academic performance in the qualifying examination prescribed for admission and seniority of their age</p> <p>7. In case of the seat is not filled, next candidate in the merit list shall be offered the seat</p>
