Sub: Ban on use of one time use-and-throw plastic items from 01.01.2019 Implementation of the order of Tamil Nadu Government.

It is informed that our Deemed University has decided to implement the Tamil Nadu Govt. order in relation to ban on use of "one-time-use-and-throw-away- plastic-items" from 01.01.2019 and the following steps would be taken, as requested by the Tamil Nadu Pollution Control Board Authorities:-

- 1. In the electronic display board installed at the college entrance and Medical Centre, information on
 - (a) Ban of use of "one-time-use-and-throw-away-plastics" from 01.01.2019 with pictorial representation of the banned item viz., plastic plates, plastic coated tea cups /tumblers, plastic straw, plastic flags, plastic sheets, plastic water pouches and carry bags (irrespective of thickness) will be displayed so as to inform the visitors about the implementation of the ban on such plastic items within the campus of our Deemed University; and
 - (b) Appeal to use alternate to the banned plastic items and help protect your environment and save the Earth.

(Action: DOF office/CHA, SRMC)

Printouts taken on white sheets with the words "PLASTIC FREE ZONE" will be stuck
in the entrance of each blocks in our Deemed University campus and other
conspicuous places.

(Action: GM (Infra)/Maintenance Dept./Environmental Health Engineering Dept)

 Awareness programs on the ban of "one-time-use-and-throw-away-plastics" will be conducted, utilizing the services of a proactive NGOs, NGC, ECO clubs, in the campus of the Deemed University.

(Action: Environment Health Engineering)

4. Similar awareness programs on the ban of "one-time-use-and-throw-away-plastics" will be conducted, in and around the villages adopted by our Deemed University wherein information on the alternatives for the banned plastic items will also be provided.

(Action: Coordinators of NSS/NCC units in consultation with Environmental Health Engineering Department and Community Medicine Department)

5. An exhibition may be conducted to create awareness among the students on the ban of "one-time-use-and-throw-away-plastics-items", by exhibiting various models/drawings prepared by the students of the colleges of our Deemed University. The Dean SRMC & RI will convene a meeting with the Heads of Constituent Units/Colleges of our Deemed University and finalize the details of duration and dates of the exhibition, items permitted to be exhibited, etc., in consultation with all concerned.

(Action: Dean, SRMC & RI, Heads of the constituent colleges)

6. A program may be arranged by the Heads of Institutions of the Deemed University on 24.12.2018, wherein the students will take pledge to the effect that "we will not use the one-time-use-and-throw-away-plastic-items and that we would help

propagate the ban of such plastic items among my family members and neighbours". Heads of respective constituent units/colleges of our Deemed University will arrange for conduct of this 'pledge-taking-ceremony' in their respective colleges.

- 7. All Heads of constituent Colleges/Officers concerned are requested to take short videos and photographs of the above said activities and send them by email to the HOD, Environmental Health Science Dept. (hod.ehe@sriramachandra.edu.in) for compilation and marking a copy of the same to the Vice-Chancellor (vc@sriramachandra.edu.in) for information.
- 8. A Committee is formed (as given in the Annexure) to monitor the activities and it will visit the various blocks in our Deemed University, including canteens, student mess, cafeteria etc., and ensure that the ban of "one time use-and-throw-away-plastic-items" are strictly complied with. Any deviation should be brought to the notice of the Vice Chancellor immediately.
- 9. Co-operation of all Deans/Principals/Heads of departments, faculty members, employees, and students is requested to ensure that the entire campus of our Deemed University is maintained as a PLASTIC FREE ZONE strictly. Every small effort taken in this regard by those who use the facilities inside on campus every day, would be much appreciated as it would go a long way to protect our environment and save our Mother Earth.
